How to Pay Your Property Tax Online – ONE TIME PAYMENT

There are two approaches to pay online: 1) One-time Payment 2) VIP Taxpayer using eNoticesOnline

- 1) One-time Payment is the traditional way to make an online payment. You can use eCheck (FREE) or credit/debit card (Debit Card-\$4.00 or Credit Card-2.4% fee).
- 2) VIP Taxpayer using eNoticesOnline - you can use eCheck (FREE) or credit/debit card (Debit Card-\$4.00 or Credit Card-2.4% fee) and it offers the following benefits:
 - Multiple notifications to remind you to make payment for each of the 2 property tax installments (1st due date is June 10 and the 2nd installment is September 10). Once you have made payment, or set up a scheduled payment, the notifications cease.
 - Make a scheduled payment for each installment. This allows you, for example, to set up a payment in May for funds to be withdrawn from your bank account or debited to your credit or debit card, on a specific date PRIOR to, or ON the due date.
 - You will receive future tax bills electronically. This allows you to electronically store and manage your tax bill and replaces the mailed original paper tax bill.
 - Access and manage all your McHenry County property tax payments and bills in a single account. This provides a great repository for all, and especially for those who have multiple properties that they are managing.
 - You can opt out of being a VIP Taxpayer at any time.

How to make a ONE TIME PAYMENT:

1. Go to treasurer.mchenrycountyil.gov and select either Look Up / Pay Your Tax Bill or click on the red button – PAY YOUR TAX BILL ON LINE.




2. Enter your parcel number/PIN **or** search by name **or** address.




3. Select the **Pay Taxes** – green button (the **Tax Bill** green button - allows you to download a duplicate PDF tax bill for your records or to print. Please note the tax information is the same, but the format is different from the bill you receive in the mail). OR you can select the blue **Pay Taxes** menu option on the right of the screen.

NOTE:
With e-Check or debit transactions, 'Approved' means the transaction was received to be processed. Your bank could return/reject payment, i.e. NSF, closed account, no account, etc.

You can search by: Name, Address, or Parcel Number.



5. Click **Add** to place installments in cart.

6. Once you click Add, the button turns to red and says **Remove**. (Click Remove if you do not want to make payment as this time). Keep in mind that you must add the 1st Installment first. Then you can Add the Second-Half Due if you want to pay both installments at the same time. The system will not allow the Second-Half Due to be paid before the First-Half Due is paid. Once you are read to pay, click **View Cart**.

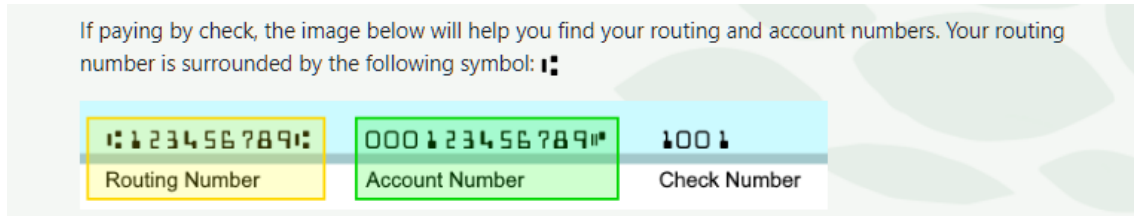
